Steel Guard is non-staining and applies easily, using the same application procedures as form release agents. Steel Guard is solvent free in composition to reduce the risk of inadvertent soil contamination.

DIRECTIONS FOR USE: Steel Guard storage release may be used on all steel or metal forms and equipment including ferrous, non ferrous and galvanized surfaces. Steel Guard is ready to use and should not be diluted prior to application. Apply by spray, roller, brush or wiping onto clean, dry surfaces, making sure that all exposed metal is completely covered. Approximate coverage rate is 800 to 1000 square feet per gallon on most hard surfaces. Steel Guard sprays easily, even in colder temperatures. When placing stored forms back in service, Steel Guard does not have to be removed. Simply wipe off any accumulated contaminates and apply MSP OIL release agent. Steel Guard should provide a minimum 4-5 months protection, depending on environmental conditions. For extended storage or severe conditions, re-coat as necessary.

CAUTIONS: Apply Steel Guard to clean, dry metal surfaces. Never use compressed air to force the material from the drum. Avoid the introduction of compressed air into the container under all circumstances.
